Accessible 24/7 Addiction Treatment and Support at Margaretville Hospital

Our Services

Margaretville Hospital Emergency Department provides immediate access to buprenorphine, a medication used in the treatment of Opioid Use Disorder. Addiction treatment and recovery support are available to anyone who needs it, wherever they are on their path to recovery. Support is also available for loved ones. Services include:

- Compassionate, non-judgmental addiction treatment and support.
- Peer Recovery Advocate Services provide confidential, compassionate addiction support at the hospital and in the community.
- Addiction psychiatry and outpatient addiction treatment licensed by the New York State Office of Addiction Services and Supports.
- Overdose prevention through distribution of free naloxone kits with instructions for use.

• Seamless referrals to follow-up outpatient care.

Skilled and compassionate follow-up addiction treatment is available through the MidHudson Regional Hospital Turning Point Outpatient Program, which is licensed by the New York State Office of Addiction Services and Supports.

Our Treatment Philosophy

We provide a trauma-informed, whole-patient approach to substance use and recovery. We believe that addiction is a disease that can be managed with a variety of strategies, including abstinence, medication-assisted treatment, counseling, cognitive/behavioral therapies, and coaching from people with lived experience. There are many paths to recovery, and our mission is to support patients as they determine which path is best for them. Our goal is to reduce the harm of substance use by meeting people wherever they are in their recovery with compassion and without judgment.

Access

Addiction treatment is available 24/7 at the Margaretville Hospital Emergency Department. Outpatient follow-up by Turning Point providers can be accessed remotely through personal devices. Peers are embedded in the community to provide addiction support and coaching when and where you need it.
